



**Little Village Nursery School (LVNS)**

**FINANCIAL AID APPLICATION**  
**September 2010- August 2011**

**OVERVIEW**

**1) Financial Aid is available to admitted students for Morning and Afternoon Program tuition only.**

*Applicants are required to be admitted to LVNS prior to applying for financial aid. Extended Day school and any other school-related fees are not eligible for financial aid under this application.*

**2) Financial Aid is available to families that earn up to or LESS THAN the average household, gross incomes specified below.**

*Parents or guardians living in separate households are required to complete Household Income Calculations, tax returns and current pay stubs for both parents and/or guardians to determine eligibility.*

**3) All Financial Aid Applicants are required to submit the following documentation to be considered for eligibility:**

- Financial Aid Application
- 2009 Tax Return(s) (Individuals or Jointly as applicable for family)
- A copy of Applicant(s) most recent pay check stub
- Projected income and expenses for 2010

*Applications received after April 30, 2009 will be considered for temporary Emergency Aid.*

**6) Financial Aid applications are reviewed on a first-come, first-served basis and awarded based on financial aid availability, number of applicants and financial need.**

**7) Financial Aid will be determined and awarded on or before June 30, 2010 for the 2010-11 Program Year.**

*All monies granted are exempt from repayment based on continuous eligibility of applicants.*

**FINANCIAL AID APPLICATION GUIDELINES**

- 1) All applications will be reviewed by the Financial Aid Committee in strict confidence.**
- 2) Financial Aid will have NO bearing on acceptance to LVNS or its program(s).**
- 3) Financial Aid policies may be reviewed and changed at the discretion of the Financial Aid Committee from time to time to provide the best possible financial aid options to families in need.**
- 4) Financial Aid is granted for one year and must be applied for each year for the following school year. Financial aid does NOT carry over to the granted child(ren) or other siblings attending LVNS in future school years. If more than one child in a family is eligible for a grant, each child will be awarded financial aid in an equal amount.**
- 5) If at any point during a financial aid period a family's financial situation improves, such that their gross income is above the income requirements set forth above, the applicant(s) are required to notify the Financial Aid Committee in writing and the remainder of the family's aid for the school year will be revoked.**
- 6) All adjusted or partial tuition payments must be made in a timely manner, or financial aid may be suspended or revoked.**
